GENERAL INFORMATION

City Council ordered a special election with Resolution #13-2025, for a bond election with one measure on the ballot.

Measure A, \$20,000,000 for the purpose of designing, expanding, constructing, renovating, improving, updating, upgrading, and equipping airport improvements at the City airport, including the terminals, runways, taxiways, roadways, aprons, fuel centers, parking lots, and other facilities incident and related to the operation of the City's airport, and acquiring lands, and the acquisition of land, easements, rights-of-way, and other real property interests necessary thereafter or incidental thereto.

The bond measure passed with 52.18% of the vote.

RESOLUTION NO. 87-2025

A RESOLUTION CANVASSING THE RETURNS AND DECLARING THE RESULTS OF A BOND ELECTION; AND OTHER MATTERS IN CONNECTION THEREWITH

WHEREAS, the City Council (the *Council*) of the City of Abilene, Texas (the *City*) ordered an election to be held on May 3, 2025 for the purpose of determining whether the qualified voters of the City would authorize the issuance of general obligation bonds by the City; and

WHEREAS, the Council has reviewed and investigated all matters pertaining to this election, including the election resolution, notices, officers, holding, and returns thereof; and

WHEREAS, the Council has diligently inquired into the poll lists and the official election returns which were duly and lawfully made to the Council by the judges and clerks holding and conducting such election; the poll lists and the official election returns showing separately the votes cast in the election; and

WHEREAS, the precinct returns are attached and incorporated for all purposes; and

WHEREAS, from these returns, this Council hereby finds that the following votes were cast in the election by voters who were qualified voters of the City:

PROPOSITION A

The issuance of bonds in the amount of \$20,000,000 for airport improvements and the levy of taxes sufficient to pay the principal of and interest on the bonds.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ABILENE, TEXAS THAT:

SECTION 1: The Council officially finds, determines, and declares that the election was properly ordered, that legal notice of such election was properly given, that proper election officers were appointed prior to the election, that the election was legally held, that all qualified voters of the City were permitted to vote at the election, that due returns of the results of the election had been made and delivered, and that the Council has duly canvassed such returns, all in accordance with state and federal laws and the document calling the election.

SECTION 2: A MAJORITY of the qualified voters of the City of Abilene, Texas voting in such election, having voted FOR Proposition A, the Council hereby finds and determines this Proposition carried at the election, and that the Council is hereby accordingly authorized to issue the bonds and to levy the tax in accordance with the law and the authority granted in the Proposition and corresponding Measure stated in the City's election order.

SECTION 3: The City's Mayor is authorized to execute this Resolution, and the City's Secretary is authorized to certify this Resolution regardless of their participation in the quorum required by the Election Code.

SECTION 4: The recitals contained in the preamble of this Resolution are hereby found to be true, and such recitals are hereby made a part of this Resolution for all purposes and are adopted as a part of the judgment and findings of the Council.

SECTION 5: All resolutions and resolutions, or parts thereof, which are in conflict or inconsistent with any provision of this Resolution are hereby repealed to the extent of such conflict, and the provisions of this Resolution shall be and remain controlling as to the matters resolved herein.

SECTION 6: This Resolution shall be construed and enforced in accordance with the laws of the State of Texas and the United States of America.

SECTION 7: If any provision of this Resolution or the application thereof to any person or circumstance shall be held to be invalid, the remainder of this Resolution and the application of such provision to other persons and circumstances shall nevertheless be valid, and the Council hereby declares that this Resolution would have been enacted without such invalid provision.

SECTION 8: It is officially found, determined, and declared that the meeting at which this Resolution is adopted was open to the public and public notice of the time, place, and subject matter of the public business to be considered at such meeting, including this Resolution, was given, all as required by Chapter 551, as amended, Texas Government Code.

SECTION 9: This Resolution shall be in force and effect from and after its final passage and it is so resolved.

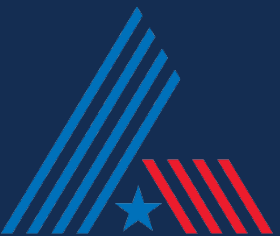

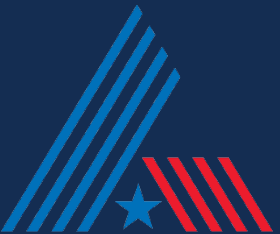

GENERAL INFORMATION

On February 14, 2025, the City Council ordered a general election to be held on May 6, 2023, for the purpose of electing one councilmember from Place 5 one councilmember from Place 6.

Texas Election Code, Title 6, Chapter 67, Section 67.002, requires that for an election ordered by an authority of a political subdivision other than a county, the political subdivision's governing body must canvass the results. Approval of this item will meet that requirement.

The results provided by Taylor County report that no single candidate received the majority of votes for Place 5, and Travis Craver received the majority of votes for Place 6. Therefore a runoff election must be held for Place 5.

The runoff election will be held on June 6, 2025.

The City Charter, Article III, Section 27, provides, in part, that "*... a qualified person receiving a majority of the votes cast for any office shall thereupon be declared elected by said council.*"

WHEREAS, That the canvass and tabulation of votes cast at the election for 2 members of the city council, held May 3, 2025, discloses that the following candidate received a majority of the votes cast at the election in his respective place:
