- a. Bi-Annual visit overview & introduction of inspectors in attendance – Present at meeting. Visit underway to evaluate if local CAC is meeting state standards.
 - b. Status of Funding Outlook – VOCA funding has decreased 67% since 2018 and sustainability concerns have been raised. Bill HR 909 redirects funds to sustain VOCA funds
 - c. Overview of hiring process to be used to find next CAC Director – Will utilize the defined hiring process as defined by City of Abilene. Annette Lerma and Jeff Cook will review job description and post. 90 day goal is currently in place and will be adjusted if need arises.
