GENERAL INFORMATION

On February 12, 2026, the City Council ordered a general election to be held on May 2, 2026, for the purpose of electing one councilmember from Place 3 one councilmember from Place 4, and the Mayor.

Texas Election Code, Title 6, Chapter 67, Section 67.002, requires that for an election ordered by an authority of a political subdivision other than a county, the political subdivision's governing body must canvass the results. Approval of this item will meet that requirement.

The results provided by Taylor County report that no single candidate received the majority of votes for Place 4. Therefore a runoff election was held on June 13, 2026.

The City Charter, Article III, Section 27, provides, in part, that "*... a qualified person receiving a majority of the votes cast for any office shall thereupon be declared elected by said council.*"

The results provided by Taylor County for the June 13th runoff election reported that Benjamin Bailey received the majority of the vote for City Council Place 4, and is therefore duly elected.
